I, the undersigned, understand and agree to the following:

1. Retail list price of the rented instrument is \$_____.
2. If the instrument is lost or irreparably damaged, renter is responsible for 70% of the amount of the retail list price of the instrument.

3. All repairs and adjustments are to be made only by Old Town Violins agents. Repairs necessary due to normal wear and tear will be assumed by Old Town Violins providing rental payments have been made timely and are current. Repairs necessary due to damage deemed over and above normal wear and tear will be performed by Old Town Violins at the expense of the renter. Accessories, replacement strings, etc are beyond the scope of this agreement and are the renter's responsibility. Shipping charges to Old Town Violins are the responsibility of the renter. Return shipping to the renter will be \$15, and will be charged to the credit/debit card on file.
4. Exchanges to the next instrument size shall be free of charge providing rental payments are current and the previous instrument is returned in good condition with only normal wear and tear. Shipping charges to Old Town Violins are the responsibility of the renter. Return shipping to the renter will be \$15, and will be charged to the credit/debit card on file.
5. If rent is not paid for two consecutive months due to the renter's debit/credit card being denied and not replaced, and/or the instrument is not returned in good condition allowing for normal wear and tear, the renter shall be responsible for 70% of the retail list price of the instrument plus any and all collection or legal fees incurred.
6. Minimum rental term is six months. If rent is paid on time and is current, and the rental instrument is returned in good condition allowing for normal wear and tear, 100% of rental fees (up to 24 months maximum) may be applied to the purchase price of a "step-up" instrument equal to twice or greater of the value of the list price of the rental instrument. This does not mean "rent to own" the rental instrument.
7. Rental fees are due on the 1st day of each month, and will be charged to the credit/debit card on file. Partial months at the beginning of the agreement will be prorated. A late fee of \$5 per day will be charged on payments received by Old Town Violins more than 10 days past the due date.
